
PRIVACY POLICY

Considering the commitment of the Fundação Getúlio Vargas in maintaining the privacy of our web portal users, we created this privacy policy to show you the reasons why we collect information on our users when browsing our pages. Therefore, we shall explain the whole procedure, from data collection, to how we use your information.

We request you read this document, and keep in mind that to safeguard your privacy, this policy may change accordingly. So we ask you to consult it, from time to time.

When you start browsing our links page, your IP is retained and a cookie is added to your computer. The IP address is a numerical label assigned to your computer and which is used by us for security purposes.

Cookie is a piece of text stored by a user's web browser which is used to retain non-secretive data (used browser, version, monitor definition and intentions within our portal) from your computer, in order to understand your intentions and provide you with a better browsing experience. It should be noted that these data are not used separately, but in conjunction with other users, resulting in non-individualization and therefore maintaining your privacy. Through your browser, you may delete this cookie at all times.

We have collected in some parts of our portal, in a fully spontaneous manner and upon your consent, personal data such as name, phone number, e-mail, company, city and state, in case you wish to receive more information concerning the Fundação's courses, products and services. This is necessary in offering you tailor made material, apart from facilitating your contact and query solving.

There are, within the links page of the Fundação Getúlio Vargas, some areas of restricted use which can be accessed using passwords supplied by the institution. The user should contact us through our e-mail address marketing@fgv.br in case his/her account has been accessed by third parties or without permission. The user should also make sure not to leave his/her account open when not using it, or when leaving the computer unattended, thus avoiding access of third parties.

We guarantee that only Fundação Getulio Vargas has access to your collected information, which shall not be revealed to third parties, with this occurring only upon your consent or by force of law, of the competent authorities, or judicially.

According to your interest when browsing our links page, we can send you e-mails concerning new information on products and services. No other entity is authorized to send you e-mails in the name of the Fundação Getulio Vargas, and in case you wish not to receive further e-mails from us, you will find in the footnotes options to unregister yourself from the mailing list, with these messages ceasing within two working days, or up to five, when requested through other channels.

The issuers of the e-mails in question, which may contain attachments, are easily identified, and these shall contain a valid e-mail address for contact purposes with the subject being in accordance with the content of the message.

FGV is the only and exclusive holder of the intellectual property of the documents available within its website, and when this is not the case, the name of the holder shall be highlighted in the document.

In this act, the user shall declare that he/she is aware that the use of information contained in the website is exclusively for non-commercial purposes, with its disclosure only being allowed following FGV's manifested and prior approval.

FGV does not take responsibility regarding the contents, privacy policy and related issues concerning websites of links made available.

FGV encourages the development and use of the Self-Governance Code for E-Mail Marketing Practice, and hereby declares that it shall undertake all efforts, so that all forms of electronic communication used by the Fundação comply with the standards of self-governance, enabling the ethical correctness of e-mails.
